**Call for Applications No. 3/2022/PPGFSC**

**SELECTION PROCESS FOR ADMISSION TO THE DOCTORAL PROGRAM IN PHYSICS**

The Coordinator of the UFSC Graduate Program in Physics (PPGFSC/UFSC), in the exercise of his statutory duties, attributed by the Normative Resolution No. 154/2021/CUn, of October 4, 2021, Normative Resolution No. 57/2019/CPG, of November 28, 2019 and Resolution No. 31/2019/CPG, of June 7, 2019, makes public and establishes the rules for the application process destined to select students for admission to the PPGFSC Doctoral Program.

**1. PURPOSE**

1.1. This call for applications initiates the selection process for admission to the PPGFSC/UFSC Doctoral Program, whose aim is to provide scientific and professional development through advanced studies and scientific research.

**2. SCHEDULE**

- I. Call for applications on the program's website and notice board: May 18, 2022.
- II. Application period: from **May 18, 2022** to **June 27, 2022** at 5 pm (all times are given in Brazilian Standard Time, UTC -3).
- III. Approval of applications: June 30, 2022 after 5 pm.
- IV. Period for appealing the application decision: from June 30, 2022 to July 5, 2022 at 5 pm.
- V. Release of approved applications after analyzing the appeals: July 6, 2022 after 5 pm.
- VI. Final result: July 18, 2022 after 5 pm.
- VII. Period for appealing the final result: from July 18, 2022 to July 21, 2022 at 5 pm.
- VIII. Release of final results after analyzing the appeals: July 25, 2022 after 5 pm.
- IX. Pre-registration period: from August 15, 2022 to August 19, 2022.

### 3. APPLICATION PROCEDURES

3.1. Eligible applicants must hold a bachelor's or licentiate degree in physics or in exact sciences and/or engineering fields.

3.2. To apply for admission to the doctoral program, the applicant must do the following:

- I. **Fill in the online application form**, available at: <https://capg.sistemas.ufsc.br/inscricao/home.xhtml>
- II. Attach the following documents to the online form:
  - a) **Digitized copy of official identification document with photo (e.g. passport);**
  - b) **Digitized copy of the bachelor or licentiate degree certificate (double-sided).** For application purposes, exclusively for applicants who opted for the “direct doctoral admission” in their application form, other documents certifying that the degree will be completed before the date of registration in the PPGFSC/UFSC, as established in the UFSC 2022/2 academic calendar, will be accepted;
  - c) **Digitized copy of the master’s degree certificate (double-sided).** For application purposes, other documents certifying that the degree will be completed before the date of registration in the PPGFSC/UFSC, as established in the UFSC 2022/2 academic calendar, will be accepted;
  - d) **Digitized copy of updated undergraduate transcript** (exclusively for applications to the direct doctoral admission);
  - e) **Digitized copy of updated master’s transcript;**
  - f) **Proof of registration in the Unified Exam of Graduate Studies in Physics** (known in Portuguese as Exame Unificado de Pós-graduações em Física, or by its acronym EUF). It is necessary to attach a scanned copy of document containing the registration number;
  - g) **Digitized version of Curriculum vitae in free format.** Brazilian applicants should attach a digitized copy of the *Curriculum Lattes/CNPq*, updated and available at <http://lattes.cnpq.br/>;
  - h) **Digitized copy of the that prove the bibliographic production included in the curriculum;**
  - i) **Quantitative list of bibliographic production for curriculum analysis, duly completed** (see Annex 1).

3.3. The online registration form will only allow uploading PDF files, with a limit of 20 (twenty) megabytes per file.

3.4. No late submissions, or submissions by fax, mail or similar means will be accepted.

3.5. The candidate must inform in the online registration form (see item 3.2) his/her enrollment number in the Unified Exam of Graduate Studies in Physics (EUF) and the month and year in which he/she took the EUF.

3.6. A single registration number corresponding to any edition of EUF in 2020, 2021 and 2022 will be accepted.

3.7. In case more than one application from the same applicant is received, only the most recent application will be considered.

#### 4. THE SELECTION PROCESS

4.1. The selection process for the doctoral applicants will consist of two partial grades: the EUF normalized grade (N1) and the *curriculum* evaluation (N2).

4.2. The final grade (NF) will be the sum of N1 and N2 ( $NF = N1 + N2$ ).

4.3. The EUF normalized grade (N1) will be calculated by the formula:

$N1 = [(EUF\ Grade \times 4.0) / (EUF\ Average)]$ , where the "EUF Average" refers to the average grade over all EUF participants in that edition. The N1 grade will be calculated to the second decimal place.

4.4. The applicant who obtains N1 lower than 1.5 (one point five) will be disqualified.

4.5. The N2 grade consists in the *curriculum vitae* analysis.

4.6. For the purpose of scoring the *curriculum vitae*, an indexed journal is considered to be one that is indexed in Scopus, Scielo, Web of Science or present in CAPES Qualis.

4.7. **To score curriculum items, it is essential to present supporting documentation.** The applicant's *curriculum vitae* has to be sent along with supporting documents for all bibliographical production described in the CV, which will be analyzed by the Selection Committee according to the following criteria:

- I. **Article published/accepted in an indexed scientific journal** (To score it is necessary to provide a digitized copy of the paper's first page):
  - 1.0 (one point zero) point if Qualis CAPES A1 or A2;
  - 0.8 (zero point eight) point if Qualis CAPES B1 or B2;
  - 0.5 (zero point five) point if Qualis CAPES B3, B4 or B5;
  - 0.25 (zero point twenty five) point if Qualis CAPES C.
  
- II. **Article submitted for publication in an indexed journal** (To score it is necessary to present a digital proof of submission and a digital copy of the first page of the work and proof of association with the supervisor/co-supervisor):
  - 0.2 (zero point two) point. Limited to 2 (two) articles.

III. **Publication in conference annals** (To score it is necessary to present a digital proof of submission and a digital copy of the first page of the work and proof of association with the supervisor/co-supervisor):

- 0.2 (zero point two) point for full papers (at least two pages). Abstracts will be disregarded.

IV. **Presentation in conferences** (To score it is necessary to provide the digitized copy presentation certificate):

- Conferences: presented by the candidate: 0.30 (zero point three) for each oral presentation; 0.10 (zero point one) point for each poster presentation;
- Co-authorships of presented works will be disregarded;
- Maximum of 0.6 (zero point six) point for this item.

V. **Organization of scientific conference** (To score it is necessary to provide a digitized certificate):

- Member of local organizing committee or scientific organizing committee: 0.15 (zero point fifteen) point;
- Maximum of 0.3 (zero point three) point for this item.

VI. **Undergraduate research project** (To score it is necessary to present a digitized certificate):

- 0.25 (zero point twenty-five) point per semester of undergraduate research project;
- 0.1 (zero point one) point per semester of Tutorial Education Project (PET), Undergraduate Teaching Project (PIBID) and Supervised extension activity;
- Maximum of 1.0 (one point zero) point for this item.

4.8. For scientific articles, the Qualis CAPES assignments for the most recent Astronomy and Physics area of the last two CAPES evaluations will be considered. In case there is no classification in the area of Astronomy and Physics, classification in related areas will be considered.

4.9. Articles submitted to indexed journals which have not yet received a decision letter will only be considered if the submission occurred within 12 months prior to the deadline for registration in the selection process and which are co-authored by the student's supervisor. Rejected manuscripts will be disregarded.

4.10. Presentations in conferences will be computed as poster presentations unless the form of oral presentation is explicitly stated in the certificate.

4.11. Information posted in the curriculum whose supporting documents are missing when submitting the application will be disregarded during the analysis of the curriculum, as well as documents which cannot be clearly attributed to the candidate.

4.12. The maximum total score for the N2 grade will be 2.0 (two point zero) points.

## **5. AFFIRMATIVE ACTIONS POLICY**

5.1. According to Normative Resolution No. 145/2020/CUn, of October 27, 2020, which provides for the policy of affirmative actions for blacks (blacks and browns), indigenous people, people with disabilities and other categories of social vulnerability in the graduate courses *lato sensu* and *stricto sensu* at the Federal University of Santa Catarina, at least 28% (twenty-eight percent) of the scholarships available annually will be reserved for the implementation of this policy.

5.2. Fractions will always be rounded up to the next whole number when computing the number of places reserved for affirmative action.

5.3. If the number of scholarships granted by the funding agencies does not meet the proportion established in 5.1, the remaining fraction will be carried over to the next selection process of the current year.

5.4. The candidate must, when filling out the online registration form, tick the specific field for the affirmative action policy, choosing only one of the following categories:

- I. Blacks (Black and Brown);
- II. Indigenous people;
- III. People with disabilities;
- IV. Quilombolas;
- V. Beneficiaries of the University for All Program (PROUNI) of the federal government, or beneficiaries of a scholarship aimed at undergraduate students, from public universities, who are in a situation of socioeconomic vulnerability.

5.5. The candidate must send, through the online registration form, in addition to the documents listed in item 3.2 of this notice, the following document(s), according to the option chosen in item 5.4:

### **5.5.1. Scholarships for blacks and browns:**

- I. Self-declaration that he/she is black or brown, according to the color or race item used by the Brazilian Institute of Geography and Statistics - IBGE for candidates opting for vacancies for blacks (blacks and browns), Annex 2.

The validation of the self-declaration of black or brown will be made by the selection committee or Committee for Heteroidentification of Phenotype, which may rely on the assistance of the Secretariat of Affirmative Diversity Actions - SAAD, with the following criteria: self-declared blacks or browns must have phenotypic aspects that characterize them as belonging to the black racial group. According to the Federal Supreme Court, in the vote on the constitutionality of the Action for Noncompliance with Fundamental Precept No. 186, the criterion is the phenotype and not ancestry.

### **5.5.2. Scholarships for indigenous people:**

- I. Self-declaration that he/she is indigenous, to which ethnicity he/she belongs, the name and municipality of the village and the state of the federation, contained in Annex 3;

- II. Copy of the Administrative Record of Birth of Indigenous People (RANI) or declaration of belonging issued by the indigenous people, recognized by FUNAI, signed by a recognized indigenous leader.

The validation of the indigenous self-declaration will be confirmed by the selection committee, which may rely on the assistance of the Secretariat for Affirmative Diversity Actions – SAAD.

#### **5.5.3. Scholarships for quilombolas:**

- I. Self-declaration that he/she is quilombola, name of the quilombola community, municipality and state of the federation, contained in Annex 4;
- II. Document proving residence / belonging to the remaining quilombo communities, signed by a member of the Quilombola Association board recognized by Fundação Palmares.

The quilombola's self-declaration will be validated by the selection committee, which may rely on the assistance of the Secretariat for Affirmative Diversity Actions – SAAD.

#### **5.5.4. Scholarships for people with disabilities:**

- I. Medical report, made no later than twelve months prior to inscription in this selection process, which must be signed by a specialist physician in the candidate's disability area, containing, in the clinical description, the degree or level of disability, with express reference to the corresponding code of the International Classification of Diseases – ICD and description of the impact of the disability on functionality. It must also contain the legible name, stamp, signature and license number of the doctor who provided the certificate.
- II. Candidates with Hearing Impairment (Deafness), in addition to the medical report, must be presented: audiometry (tonal and vocal) and immittance testing, the following exams performed in the twelve months prior to inscription in this selection process, in which the legible name, stamp, signature and license number of the professional who performed the exam.
- III. Visually Impaired Candidates, in addition to the medical report, an ophthalmological examination showing the visual acuity must be presented, performed no later than twelve months prior to inscription in this selection process, as well as the readable name, stamp, signature and license number of the professional who performed the exam.

The documentation of candidates classified for the vacancy of a person with disabilities will be made by the selection committee, which may count on the assistance of the Secretariat for Affirmative Diversity Actions - SAAD. The committee may, if necessary, request candidates to provide additional documentation and / or undergo a face-to-face interview.

**5.5.5. Scholarships for PROUNI beneficiaries or scholarship beneficiaries for undergraduate students from the public university education system in a situation of socioeconomic vulnerability:**

1. Proof of having been a beneficiary of the University for All Program (PROUNI) of the federal government or beneficiary of a scholarship aimed at undergraduate students from the public university education network in a situation of socioeconomic vulnerability.

5.6. The results of the Black, Brown and Black Self-Declaration Validation Committee of candidates opting for Affirmative Actions may be published after the final result of the selection process has been released.

5.7. From the results of the Black, Brown and Black Self-Declaration Validation Committee of candidates opting for Affirmative Actions, an appeal may be filed under the terms defined by this committee.

## **6. RESULTS RELEASE**

6.1. The result of this selection process will be released online on the website: [ppgfsc.posgrad.ufsc.br](http://ppgfsc.posgrad.ufsc.br) on the date provided in the item 2 of this document.

## **7. APPEALS**

7.1. Applicants will be guaranteed the right to appeal the application approval decision and the released ranking list.

7.2. The appeal must be substantiated, consistent and follow a logical argument.

7.3. The appeal must be addressed to the Selection Committee, and submitted via e-mail to: [ppgfsc@contato.ufsc.br](mailto:ppgfsc@contato.ufsc.br).

7.4. No late appeals will be accepted. No fax, mail and/or similar appeals will be accepted.

## **8. THE SELECTION RANKING**

8.1. The final ranking list will follow the descending order of the grades obtained by each applicant.

8.2. In the event of a tie, the tiebreaker will be decided by the analysis of the applicants' academic records.

8.3. The candidate will be approved in the selection process if the final score (NF) is equal to or higher than 6.0 (six point zero).

8.4. The candidate approved in the selection process may enroll as a regular student of the program, even if he/she is not contemplated by the scholarship offer.

8.5. The candidate (a) approved in the selection process, who at the time of registration has opted for the policy of affirmative actions, will have his name listed in the general classification list containing the information of this adhesion.

## **9. PERIOD OF VALIDITY OF THE SELECTION PROCESS**

9.1. The results of this selection process will be effective from the date of results release until the date of the next semester's selection process.

## **10. GENERAL PROVISIONS**

10.1. The approval in this selection process ensures to the applicant only the expectation of the right to admission into the PPGFSC/UFSC, being this admission as well as the granting of scholarships, subject to the fulfillment of the relevant legal provisions, the strict ranking order, the scholarship committee's decision as recorded in its meeting minutes, and the term of this selection process.

10.2. The invitation for admission to the PPGFSC/UFSC doctoral program will be sent via e-mail to the applicant, to the e-mail address provided by the applicant in the online application form.

10.3. Failure to send all the requested documents will exclude the applicant from the selection process.

10.4. Applicants will not be provided with any proof of qualification in the selection process, instead the final results released on the PPGFSC/UFSC website and notice board will serve this purpose.

10.5. A student's application or admission may be canceled at any time if any statement is found to be false and/or any irregularity is detected in the supporting documents submitted with the application.

10.6. Submitting an application implies understanding and tacit acceptance of all the conditions established in this call and in other regulatory notices pertaining to this selection process, of which the applicant cannot claim ignorance.

10.7. The PPGFSC office will contact all the approved applicants, through the e-mail address provided in the application form, to inform about the pre-registration procedures. The pre-registration period is from August 15, 2022 to August 19, 2022. If an applicant decides not to enter the PPGFSC, he or she shall send an e-mail to [ppgfsc@contato.ufsc.br](mailto:ppgfsc@contato.ufsc.br) informing the withdrawal.

10.8. The applicant who is granted a scholarship and does not pre-register at the PPGFSC office within the pre-registration period will have the scholarship canceled and the next applicant in the ranking list will be contacted.

10.9. The candidate who chooses the option "doctoral admission with prior master's degree" in the online application form for the PPGFSC/UFSC selection process, when entering the doctoral



course, must present, until 5 (five) business days before the beginning of the 2022/2 academic semester, copy of the document proving the completion of the master's degree or proof that the defense date is set for up to 30 (thirty) days after the beginning of the 2nd semester of 2022, defined by the UFSC academic calendar for Graduate Programs.

10.10. The candidate who chooses the “direct doctoral admission” option in the online application form for the PPGFSC/UFSC selection process, when entering the doctoral course, must present, until 5 (five) business days before the beginning of the 2022/2 academic semester, copy of the undergraduate diploma, or proof of degree conferral, or a statement indicating that the degree will be conferred within 30 (thirty) days after the beginning of the 2nd semester of 2022, defined by the UFSC academic calendar for Graduate Programs.

10.11. Failure in presenting at least one of the documents listed in item 10.9 or 10.10, within the stipulated period, will result in the disqualification of the applicant.

10.12. The PPGFSC/UFSC will release, whenever necessary, calls, complementary rules and official notices about the admission process.

10.13. Situations not covered in this call will be referred to the PPGFSC/UFSC Selection Committee.
